**33.01 TITLE.** This ordinance may be cited as the Emergency Telephone Ordinance.

**33.02 AUTHORITY.** This ordinance is enacted under the authority of section 146.70, Wis. Stats.

- **33.03 PURPOSE.** This ordinance is enacted for the purpose of creating an emergency telephone system which can be accessed from any telephone located in the County of Dane by dialing the numbers 9-1-1.
- **33.04 ADMINISTRATION.** This ordinance shall be administered by the Public Safety Communications Department under the direction of its Director, subject to the authority of the County Executive.

- **33.05 ADVISORY BODY.** The Public Safety Communications Advisory Commission shall serve as an advisory body for the operation of the E 9-1-1 emergency telephone system.

- **33.06 DEFINITIONS.** As used in this chapter, the following words and phrases shall have the meanings indicated:
- (1) Automatic Location Identification has the meaning set forth in sec. 146.70(1)(a), Wis. Stats.
- (2) Automatic Number Identification has the meaning set forth in sec. 146.70(1)(b), Wis. Stats.
- (3) Cutover shall mean the date on which the E 9-1-1 emergency telephone system is activated by the service supplier.
- (4) E 9-1-1 Emergency Telephone System or system shall mean a sophisticated system as defined in sec. 146.70(1)(i), Wis. Stats.
- (5) *PSC* shall mean the Public Service Commission of Wisconsin.
- (6) Public Safety Answering Point has the meaning set forth in sec. 146.70(1)(gm), Wis. Stats., and in this ordinance refers to the four (4) Public Safety Answering Points operated by Middleton, Monona, Sun Prairie, and Dane County.
- Service supplier shall mean that (7) telecommunications utility which directly contracts with Dane County to provide the E 9-1-1 emergency telephone system to Dane County residents. The service supplier may have a contractual relationship with other telecommunications utilities serving County's E 9-1-1 emergency telephone system area and to the extent permitted by law, such other telecommunications utilities are included within the term *service supplier* as used herein.
- (8) Telecommunications utility has the meaning set forth in sec. 196.01(10), Wis. Stats. [History: (6) am., OA 9, 1989-90, pub. 06/30/89.]

**33.07 CONSTRUCTION OF CHAPTER.** This chapter shall be construed to be consistent with section 146.70, Wis. Stats., and acts amendatory thereto. In the event of any conflict of any part of this ordinance with said section of state statutes, the remainder of this ordinance shall not be affected thereby and to that extent all sections of this ordinance are declared to be severable.

**33.20 PLAN OF OPERATION.** There is hereby created in the County of Dane an E 9-1-1 emergency telephone system with a four (4) Public Safety Answering Points. To the extent expressly authorized by contract between Dane County and the service supplier, the system shall be partially funded through a surcharge on the telephone bills of the users of said system as permitted by sec. 146.70(3), Wis. Stats. The service supplier shall provide the essential components of such a system, including arrangements with other telecommunications utilities to allow the system to be functional throughout Dane County.

33.21 **EMERGENCY NETWORK** AND **UNIVERSAL NUMBER SERVICE: INSTALLATION OF EQUIPMENT.** The service supplier shall install and maintain an E 9-1-1 emergency telephone system and provide a universal central office number 9-1-1 for the use of public safety answering points engaged in assisting local governments within the E 9-1-1 emergency telephone system area in protecting the safety and property of the general public. The system shall operate so that, when the number 9-1-1 is dialed, it will provide the 9-1-1 system features described in section 33.24 hereof to all access lines served by central offices in Dane County.

33.22 PROVISION OF EMERGENCY NETWORK AND UNIVERSAL NUMBER SERVICE; 24 HOUR PER DAY AVAILABILITY. The features offered under the E 9-1-1 system shall be available 24 hours a day, 7 days per week.

**33.23 APPLICATION OF TARIFF.** The service supplier's provision of the services contemplated herein shall be governed by its tariff.

**33.24 NETWORK FEATURES.** The E 9-1-1 system shall have the following features: (a) Automatic Number Identification (ANI) and (b) Automatic Location Identification (ALI).

**33.25 NETWORK CONFIGURATION.** The telephone exchange areas set forth in section 33.80 hereof shall be included in the Dane County E 9-1-1 system.

**33.40 SYSTEM COSTS; ASSESSED AGAINST USERS.** The service supplier shall bill its customers within the County in amounts sufficient to recover its nonrecurring and recurring charges, as provided for in sec. 146.70(3), Wis. Stats., and in the manner allowed by PSC rules, regulations and tariffs. For purposes of determining the charges to be so billed, the service supplier shall utilize the detail set forth in section 33.81 for the initial service period.

## 33.41 USER RATES: SUBJECT TO CHANGE.

The service supplier shall review access line counts 60 days before cutover and annually thereafter. This count shall be provided to the county. The access line count shall be used as the basis for adjusting the monthly user rate. The service supplier shall timely notify the county, in writing, whenever any change is pending to its tariff, whether initiated by the service supplier, the PSC or any other person.

**USER CHARGES: SELECTIVE** 33.42 ROUTING. Telephone utility costs for establishing and maintaining the selective routing network and data base and only shall be included in any user charge authorized under this ordinance for those municipalities operating a Public Safety Answering Point which agree, by contract, to purchase Automatic Number Identification Automatic Location and Identification equipment and maintain a dual alerting protocol approved by the Public Safety Communications Department.

**33.50 LIABILITY; SERVICE SUPPLIER'S SERVICES LIMITED.** In furnishing the use of its facilities to enable the County and its personnel to respond to such calls when received by such personnel on the County's premises, the service supplier is not required to answer or forward E 9-1-1 calls.

33.51 LIABILITY; LIABILITY OF SERVICE SUPPLIER TO THIRD PARTIES. This ordinance is not intended, nor shall it be construed, to create, amend, abridge, modify or in any other way affect any obligation or liability of the service supplier, by way of civil action or otherwise, to third parties, including members of the public, for injuries, death or loss to persons or property resulting from its acts or omissions or for its suppliers' acts or omissions under this ordinance.

**33.80 EXCHANGE AREAS COVERED BY E 9-1-1 OPERATIONAL PLAN.** The E 9-1-1 system established herein shall be provided to all telephone users in the following telephone exchanges:

- **33.81 USER CHARGES.** The service supplier is hereby authorized to assess the following charges against telephone lines located in Dane County, except that no charges are authorized against lines of the State of Wisconsin.
- (1) Nonrecurring charges. Total nonrecurring charges of \$639,428.12 shall be recovered by the service supplier over a period of 36 months at the rate of 11¢ per month per telephone line.
- (2) Recurring charges. In addition to nonrecurring charges, recurring charges of \$29,119.20 per month shall be recovered by the service supplier at the rate of 18¢ per month per telephone line or at such other rate as may be authorized from time to time by the PSC.
- (3) Lower rates incorporated. Whenever lower rates for recovery of nonrecurring charges or recurring charges, or both, are authorized by the PSC, the same shall be deemed to be incorporated in this ordinance as though set forth herein.
